Measuring. All agility dogs are required to have an Official Jump Height Card and exhibitors must be able to present it prior to running their dog(s) in any class at any time during the trial upon request whether or not they have sent a copy of such with their entry. Dogs without a valid Jump Height Card may still compete but they must be measured/wicketed by the **Judge of Record** PRIOR to running in their class; this measurement will be valid for that weekend of trials only. The exception to this requirement is a dog entered in the 24" height division. However, if a **Volunteer Measuring Official (VMO)** or an **Agility Field Rep** is present: **ALL** dogs without a valid Jump Height Card must be measured at some time during the trial or cluster of trials. This does not preclude having the dog wicketed by the Judge of Record if the VMO or Rep is not available to measure the dog *before* its first run of the trial or cluster of trials. It is the exhibitor's responsibility to have their dog measured prior to running. Failure to do so will result in the cancellation of any qualifying scores.

Height Divisions

Owners are responsible for entering the proper height division: dogs that run at an improper height will be eliminated. *Height is measured at the withers.*

Dogs Eligible to Enter



This trial is open to all dogs over the age of 12 months that are registered with the American Kennel Club or are registerable breeds that have obtained AKC ILP numbers, except bitches in season, aggressive dogs, or dogs suffering from any deformity, injury, or illness which may affect the dog's physical or mental performance. Mixed breeds and breeds not registerable with the AKC are not eligible to enter. (Refer to Chapter 2 of the Registration and Discipline Rules for the listing of registrable breeds that may participate). Dogs of a registrable breed with an acceptable foreign registration number are eligible to participate subject to Chapter 11, Section 1 of the Dog Show Rules.

Move Ups

Dogs may be moved up to a higher class at the request of the owner, as a result of qualifying for an agility title, provided that the request is made **in writing** to the Trial Secretary. Saturday move-up requests must be received by the preceding Monday. Move-up requests for Sunday must be received by end of trial on Saturday. Such move-up entries shall be accepted subject to the availability of the class (i.e., that it is offered in the premium list and the entry limit, if any, will not be exceeded) and payment of any difference in entry fee. Dogs so moved up will be entered at the end of the running order.

Prizes and Awards

Ribbons will be awarded to the 1st through 4th place dog in each jump height in each class in Standard Titling and Jumpers With Weaves. A dark green qualifying ribbon will be awarded to all dogs receiving a qualifying score. Dogs must qualify to receive placement rosettes. The Club reserves the right to substitute prizes of equal or greater value. All prizes must be claimed the day of the show – none will be mailed.

Regular Class Information

Novice Agility & Novice Jumpers with Weaves (JWW) Classes The Novice Agility & Novice JWW classes are divided into Divisions A and B. Division A is for dogs that have never acquired any AKC Agility title. Additionally, a dog entered in Novice A must be handled by a person that has never put an AKC Agility title on any dog, and the handler must be the Owner, Co-owner, or a member of the Owner's household. Handlers that co-own a dog and have never put an AKC Agility title on a dog may enter the Novice A Class regardless of the other co-owner's AKC Agility accomplishments. Dogs eligible for Novice A may be entered in the Novice B Class at the discretion of the Owner. Division B is for dogs that have acquired the Novice Agility title, or the Novice JWW title, or for persons who have handled a dog to any AKC Agility title, and for dogs being handled by someone other than the Owner, Co-owner, or household member subject to the restrictions listed above. A dog may continue to be shown in the Novice B Class until they have acquired a qualifying score towards their Open title.

Open Agility Class Open to dogs that have acquired the Novice Agility or Open Agility titles but which have not acquired a qualifying score towards an Agility Excellent Title.

Open JWW Open to dogs that have acquired the Novice JWW title or the Open JWW title but which have not acquired a qualifying score towards an Excellent JWW title.

Excellent A Agility Class Open to dogs that have acquired the Open Agility title, and to dogs that have acquired the Agility Excellent title but have not acquired a qualifying score towards their Master Agility Excellent title.

Excellent JWW A Class Open to dogs that have acquired the Open JWW title and to dogs that have acquired the Excellent JWW title but have not acquired a qualifying score towards the Master Excellent JWW title.

Master Agility Excellent B Class Open only to dogs that have acquired the Agility Excellent title, and to dogs that have acquired the Master Agility Excellent title.

Master Excellent B JWW Class Open only to dogs that have acquired the Excellent JWW title and to dogs that have acquired the Master Excellent JWW title.

Preferred Class Information

Novice Agility Preferred (no A & B divisions) Open to all dogs that have not acquired a qualifying score towards an Open Agility Preferred title (OAP).

Novice JWW Preferred (no A & B divisions) Open to all dogs that have not acquired a qualifying score towards an Open JWW Preferred title (OJP).

Open Agility Preferred Open to dogs that have acquired the Novice Agility Preferred title (NAP), and to dogs that have acquired the Open Agility Preferred title (OAP) but have not acquired a qualifying score towards their Excellent Agility Preferred title.

Open JWW Preferred Open to dogs that have acquired the Novice JWW Preferred title (NJP), and to dogs that have acquired the Open JWW Preferred title (OJP) but have not acquired a qualifying score towards their Excellent JWW Preferred title.

Excellent A Agility Preferred Open to dogs that have acquired the Open Agility Preferred title (OAP), and to dogs that have acquired the Excellent Agility Preferred title (AXP) but have not acquired a qualifying score towards their Master Agility Excellent Preferred title.

Excellent A JWW Preferred Open to dogs that have acquired the Open JWW Preferred title (OJP), and to dogs that have acquired the Excellent JWW Preferred title (AJP) but have not acquired a qualifying score towards their Master Excellent JWW Preferred title.

Master Agility Excellent B Preferred Open only to dogs that have acquired the Excellent Agility Preferred title (AXP), and to dogs that have acquired the Master Agility Excellent Preferred title (MXP).

Master Excellent B JWW Preferred Open only to dogs that have acquired the Excellent JWW Preferred title (AJP), and to dogs that have acquired the Master Excellent JWW Preferred title (MJJP).

Preferred Classes will be run concurrently with the Regular Classes using the same course. Scoring is equivalent to that of Regular Classes except for Standard Course Time: dogs running in any of the Preferred classes will have an additional 5 seconds.

All dogs entering the Preferred Classes for the first time **MUST** enter the Novice level in both Preferred Standard and Preferred JWW regardless of their previous title level in the Regular Classes. Owners/dogs are allowed to switch back and forth between the Preferred and Regular Classes, but **not** at the same set of trials.

Notice To Exhibitors

- ✓ **There will be no familiarization period at these trials!**
- ✓ **The safety of the dogs is our primary concern.** By entering this trial, exhibitors acknowledge that they are familiar with the rules and regulations of this sport, and that their dogs are familiar with and able to perform all obstacles safely.
- ✓ **Dogs are not required to be at the show until scheduled time of judging.** All dogs not needed for further judging will be excused. The owner or handler of each dog is solely responsible for having the dog ready at ringside when it is to be judged.
- ✓ **Entry fees will not be refunded** in the event that a dog is absent, disqualified, excused, or barred from the competition by action of the Show Committee.
- ✓ **There will be a \$25.00 service charge for any returned checks.**
- ✓ **It is expressly understood that exhibitors alone are responsible** for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Show Committee, be asked to leave the show site. In such case, no refund of any fees paid will be made.
- ✓ **No entry fee will be refunded if the trial cannot open** or be completed by reason of riots, civil disturbances, fire, an act of god, public emergency, act of a public enemy, or any other cause beyond the control of the organizing committee.
- ✓ **The St. Croix Valley Kennel Club, its agents, etc., assume no responsibility** for any loss, damage, or injury sustained by exhibitors, handlers, or to any of their dogs or property and further assume no responsibility for injury to children.
- ✓ **Entry fees for bitches that come in season and injured dogs** will be refunded (minus an \$8.00/day handling fee) if a veterinarian's certificate is presented to the Trial Secretary prior to the start of judging.
- ✓ **Exhibitors should follow their veterinarian's recommendation** to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations.
- ✓ **Confirmation of entry receipt** can be obtained by enclosing a stamped, self-addressed envelope or post card with your entry. Those without complete addresses or correct postage will not be returned.

All dogs must be on leash at all times except when in the ring or when in the designated agility warm-up area.



ENTRIES WILL BE ACCEPTED USING RANDOM DRAW METHOD.

This method allows the club to guarantee worker spots. To volunteer at these trials and be considered for a worker spot, **you must enclose a volunteer sign-up form with your entry and write VOLUNTEER** on the outside of the entry's envelope. Please be aware that this does **NOT** guarantee you a worker spot.
